TRAVEL RELEASE Carefully read this release. I desire that my student (name printed below) be allowed to participate in the activities with the group listed above, including but not limited to, travel to and from the activities listed above ("Activities"). Although school transportation may be provided to and from the Activities, I desire that my student participate in and travel to and/or from the Activities via an alternative mode of transportation. This alternative mode is: (i) with my student's parent or legal guardian; by use of his or her personal vehicle, with legal driver's license; or (ii) via a commercial carrier (e.g. airlines, commercial bus or public transit, including ride-share services such as Uber, Lift, etc.). **Students are not permitted to ride in private vehicles with other students unless they are siblings.** Frisco Independent School District (the "District") will not allow any other alternative mode of transportation. The District has sole discretion to deny my student alternate forms of travel. Permitting travel on this occasion is solely for transportation to and from the Activities identified above and does not prevent the District from withholding approval for alternate travel on another occasion.

If I, the parent or guardian, are dropping off or picking up my student, I agree to "hand deliver" or "receive" my student at the predetermined pick up/drop off area (as determined by the Advisor) and sign in/out my student as necessary.

I, and my student both fully understand that transportation to and from these Activities could create risk to the health or safety of my student, including but not limited to serious injury or death. I, the undersigned, assume complete responsibility for any injury or accident that may occur to my student while traveling to or from the Activity via transportation not provided by the District (District vehicle or approved Charter Bus in lieu of Yellow Bus). In consideration of the District allowing my child to participate in the Activities and with other good and valuable consideration, the receipt of which is acknowledged, I release and waive all claims that I or my student may have against the Frisco Independent School District, its Board of Trustees, employees, agents, and representatives resulting, in whole or part, from my student traveling to and from the Activities while traveling in transportation not provided by the District, including but not limited to claims of negligence, whether sole, joint, contributory or otherwise, against the District or claims against the District arising under the Texas Torts Claims Liability Act. The release and waiver will be binding on my heirs, legatees, administrators, and assigns.
